

# MSCI PRIVATE REAL ESTATE INDEX APPLICATION FOR EU BMR REGULATED USE

### INTRODUCTION

MSCI real estate clients who wish to use MSCI Private Real Estate Indexes for EU benchmark regulation ("BMR") regulated uses must complete this application form and submit it for MSCI's review. If approved, MSCI, in its sole discretion, will issue a written authorization letter. Any BMR regulated use of any MSCI Private Real Assets Indexes, including the MSCI Private Real Estate Indexes, is strictly prohibited unless and until both MSCI and the applicant client have signed the written authorization letter issued by MSCI.

Any authorization is subject to MSCI being authorized or registered as the benchmark administrator for the relevant MSCI Private Real Estate Indexes pursuant to the BMR.

### ELIGIBILITY

The only MSCI Private Real Estate Indexes eligible for BMR regulated uses are those that are:

- Selected from:
  - the MSCI/AREF UK Quarterly Property Fund Index,
  - the MSCI UK Annual Property Index,
  - the MSCI UK Quarterly Property Index,
  - indexes and benchmarks created from the same index universes as the indexes listed above.
- Have frozen history

MSCI will provide a report of the values of any approved index at each update. This will be considered the definitive source of the MSCI authorized BMR regulated benchmark numbers.

Final written authorization letters will not be issued by MSCI unless and until MSCI is authorized or registered as a benchmark administrator for the relevant MSCI Private Real Estate Indexes pursuant to the BMR. MSCI may issue written provisional indications of MSCI's intent to provide authorization prior to this. Final authorization letters must be signed by both MSCI and the applicant client before any BMR regulated use is authorized or permitted.

Please note that the submission of this application is not permission, approval or authorization to use any MSCI Private Real Estate Indexes for any regulated uses under the BMR.
